In the event there is a non-institutional mortgage (i.e., a mortgage to a private individual, trust or corporation, rather than a bank or a loan company), we will require that a payoff and discharge be delivered at or before closing before payment can be made. This obligation to provide a discharge at closing also applies to all outstanding liens/attachments you may have, except for an institutional mortgage.

If you have a FHA mortgage, said loan will need to be paid off by the first of the month or you will usually have to pay a month of additional interest. We charge \$35.00 for wiring of mortgage payoffs and we will not wire an FHA payoff due on the first of the month without an additional month's interest if the wire cannot be sent three (3) full business days before the 1st of the month. You may receive a discount on lender's or owner's title insurance for this transaction if you have a recent prior title insurance policy for this property; however, if you do not provide us with a copy of or acceptable evidence of the same within seven (7) days of this letter we will presume you do not have an applicable prior policy.

Once we have been notified by the lender to schedule a date and time for your closing, we will contact you. If you are required to bring funds, please be aware that you will need to provide a bank check at closing payable to Olde Patriot Title & Closing Services, Inc., or to yourself to sign over at closing, if applicable, along with a driver's license or photo ID. You should understand that even though you will be paying for the cost of this work, we will not be acting as counsel for you, but as representative of the lender. Legal advice concerning questions you have about this transaction should be sought from counsel of your own choice and retained by you.
